## **MEMORANDUM OF AGREEMENT**

Between

MALAYSIAN ARMED FORCES CATALOGUING AUTHORITY (MAFCA)

And

CODIFICATION CENTER OF THE DEPARTMENT OF DEFENSE OF THE REPUBLIC OF INDONESIA (DEFENSE CODIFICATION CENTER)

## This Memorandum of Agreement is entered into By and between:

Malaysian Armed Forces Cataloguing Authority located at Kementerian Pertahanan, Jalan Padang Tembak, 50634 Kuala Lumpur, Malaysia, represented by its Director, Lt.Col Zulkefri Bin Omar RMAF, and referred to in the rest of this document as MAFCA.

## and

Codification Center of the Department of Defense of the Republic of Indonesia located at Jalan Jati 1, Pondok Labu, Jakarta - Indonesia, represented here by its Director, First Admiral Sri Nugroho.B.G, and referred to in the rest of this document as DEFENSE CODIFICATION CENTER

## WE NOTE as background information that:

- MAFCA is a Cataloguing Organization within MARKAS ANGKATAN TENTERA MALAYSIA, BAHAGIAN LOGISTIK PERTAHANAN, KEMENTERIAN PERTAHANAN.
- 2. DEFENSE CODIFICATION CENTER is a Cataloguing Organization within THE DEPARTMENT OF DEFENSE OF THE REPUBLIC OF INDONESIA.
- 3. MAFCA and DEFENSE CODIFICATION CENTER having common interest in Cataloguing have determined to enter into an agreement to cooperate in Training, Codification Data, and Codification Services.
- 4. MAFCA and DEFENSE CODIFICATION CENTER had collaborated in the past on Personnel training to their mutual benefit and that of their institution.

HENCE, on the basis of the above background, MAFCA and DEFENSE CODIFICATION CENTER now mutually agree as follows:

- 5. The cooperation between MAFCA and DEFENSE CODIFICATION CENTER shall cover areas of Personnel training, Codification Data, and Codification Services of mutual interest.
- 6. Training programs provided by MAFCA covers:
  - a. Introduction of ATM Cataloguing System Course
  - b. ATM Cataloguing Management Course
  - c. Indoctrination of ATM Cataloguing System Course
- 7. While the Codification data and Codification Services shall be prepared and forwarded in accordance with the rules established in the North Atlantic Treaty Organization Manual on Codification (herein after referred to as

NATO AcodP-1) and its subsequent changes and revisions published by the NATO Maintenance and Supply Agency (NAMSA) under the authority of the NATO Group of National Directors on Codification.

- 8. Either MAFCA or DEFENSE CODIFICATION CENTER shall, subject to applicable National laws, regulations, policies, practices, security requirements and interest, provide to other Party such Codification Data and Codification Services as may be required by latter. Each side of this agreement reserve the right of unilaterally withdrawing all or any part of this offer or transaction hereunder prior to delivery, whenever such action is deemed necessary in their national interest, by giving other Party prior written notice of the withdrawal which will take effect upon receipt of the notification by the other Party.
- 9. Both sides agree not to disclose, transfer, sell or deliver to third party, materials or information furnished under this Agreement without prior consent of the originating Party through written notification. It is understood and agreed that the disclosure of materials and information, patended and unpatended under this Agreement does not convey any intellectual property rights which may exist in such materials and information, and that all such rights will be protected.
- 10. Any or all materials and information furnished between parties under this agreement should be classified by either Party subject to equivalent (or no lower than) security classification of the originating Party. Either Party shall employ and maintain all measures necessary to preserve such security classification equivalent to those classified and employed by the originating Party throughout a period coequal with that during which the originating Party may maintain security measures.

- It is agreed that no cost will be charged for the Codification Data and 13. Services supplied under the terms of this Agreement. The cost of draft item identification prepared in accordance with the requirements of the Codification Contract Clause is, however, the responsibility of the end item manufacturer and is to be included by him in the contract price or as instructed by the purchasing authority.
- Any disagreement regarding the interpretation or application of this 14. Agreement shall be resolved by consultation between the Parties concerned, and will not be referred to any international tribunal or third party for settlement.
- This Agreement takes effect from the date of the amended at any time 15. subject to the mutual consent of the Parties. This Agreement may be terminated at any time by the mutual consent, or by either Party giving the other Party written notice of its intention to terminate it, in which case it shall terminate of this Agreement shall not be prejudicial to any of the codification activity then in progress, which will continue to be in force until the conclusion of such codification activity.
- In case of any divergence of interpretation, the English text shall prevail. 16.
